ASSIGNMENT OF TRADEMARKS

This assignment includes the right to sue and recover damages for past, present and future infringements of Assignor's rights in the Marks and to bring any proceeding in the U.S. Patent and Trademark Office or any equivalent agency in any other country for cancellation or opposition or other proceeding in connection with said mark. The right, title and interest are to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as they would have been held and enjoyed by Assignor had this assignment not been made.

Assignor agrees that it will execute, verify, acknowledge and deliver all such further papers, including any instruments of transfer and recordable assignments, and perform such other acts as Assignee lawfully may request from time to time, to perfect and vest title in the Marks in Assignee, or its successors and assigns.


