Release of Security Interest in Trademarks

This Release of Security Interest in Trademarks, dated as of **February 23, 2022** (the “Release”), is made by **Barclays Bank PLC**, as administrative agent and collateral agent (in such capacity, the “Administrative Agent”) in favor of **American Anesthesiology, Inc., a Florida corporation** (the “Grantor”).

WHEREAS, by (i) that certain ABL Pledge and Security Agreement, dated as of **July 15, 2020** in favor of the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) and (ii) that certain related ABL Intellectual Property Security Agreement, dated as of **July 15, 2020** in favor of the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on **July 16, 2020** at Reel **7000** Frame **0368**, the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor’s right, title and interest in, to and under the IP Collateral (as defined in the Trademark Security Agreement), including those Trademarks listed on Schedule I hereto;

WHEREAS, the Grantor desires that the Administrative Agent release, discharge, terminate and cancel its lien on and security interest in the IP Collateral (as defined in the Trademark Security Agreement) of the Grantor, including, without limitation, the Trademarks set forth on Schedule I hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the IP Collateral (as defined in the Trademark Security Agreement) of the Grantor, including any and all goodwill relating to the same, and assigns, transfers and conveys to the Grantor any and all of its rights, title and interests in the IP Collateral.

The Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
