Pursuant to Section 74 of N.J. Stat. § 42:2C, the New Jersey Revised Uniform Limited Liability Company Act and Section 10 of N.J. Stat. § 14A, the New Jersey Business Corporation Act

Organon USA LLC, a New Jersey limited liability company (the "LLC"), does hereby certify to the following facts relating to the merger (the "Merger") of Organon USA Inc., a New Jersey corporation (the "Corporation"), with and into the LLC, with the LLC remaining as the surviving entity of the Merger (the "Surviving Entity"):

- SIXTH: A copy of the executed Plan and Agreement of Merger will be furnished by the Surviving LLC to any member or any person having an interest in the Merger.

SEVENTH:

The Merger shall become effective immediately upon filing of this Certificate of Merger with the State of New Jersey in accordance with Section 76 of the RULLCA and Section 10 of the NJBCA.
