**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of March 2, 2022 by **WESTRIVER INNOVATION LENDING FUND VIII, L.P.**, as Administrative Agent (the “*Agent*”), in favor of **NEXT GEAR SOLUTIONS, LLC**, a Delaware limited liability company (the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of August 29, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting the Agent a security interest in and lien on certain intellectual property described therein;

**WHEREAS**, the Grantor has requested that Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of Grantor’s Intellectual Property, including the Intellectual Property identified in Exhibit A hereto as herein provided; and

**WHEREAS**, the Grantor has requested that the Agent provide a document suitable for recording with the USPTO and U.S. Copyright Office to evidence the release of the Agent’s security interests in and liens on the Intellectual Property as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under the Intellectual Property Collateral (as defined in the Grant), including the Intellectual Property identified in Exhibit A hereto, and all goodwill associated therewith, and all proceeds thereof, the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-party thereof; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO and U.S. Copyright Office.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
