RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of March 11, 2022, by COMERICA BANK, a Texas banking association ("Bank") in favor of BIN INSURANCE HOLDINGS, LLC, a Delaware limited liability company ("Grantor") with its principal place of business located at 30 N. LaSalle Ste 2500, Chicago, IL 60602.

Recital

WHEREAS Grantor granted to Bank a security interest in the trademarks described on Exhibits A attached hereto (the "Intellectual Property Collateral") under an Intellectual Property Security Agreement dated as of March 30, 2017, by and between Grantor and Bank, as amended from time to time (the "Security Agreement") and recorded US Patent and Trademark Office on April 4, 2017, at Reel/Frame 6027/0490 and on September 7, 2021, at Reel/Frame 7415/0015.

WHEREAS Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, Bank agrees to release its security interest in the Intellectual Property Collateral.

Now therefore, Bank agrees that it terminates and releases its security interest in the Intellectual Property Collateral and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral.
