WHEREAS, each of the entities listed on the signature page hereto (each a "**Grantor**" and collectively, the "**Grantors**"), as applicable, has adopted, used and are using the United States trademarks listed on the annexed Schedule A, which trademarks are registered in or subject to the trademark applications filed in the United States Patent and Trademark Office (the "**Trademarks**");

WHEREAS, pursuant to that certain First Amended and Restated Credit and Security Agreement, dated as of August 1, 2018, by and among AccuWeather, Inc., a Pennsylvania corporation (the "**Borrower**"), the Guarantors (as defined therein) party thereto, the Lenders (as defined therein) party thereto and **First National Bank of Pennsylvania**, in its capacity as the administrative agent for the Lenders (in such capacity, the "**Administrative Agent**"), as amended by that certain (i) First Amendment to First Amended and Restated Credit and Security Agreement, dated as of August 14, 2019, by and among the Borrower, the Guarantors, the Lenders and the Administrative Agent, (ii) Second Amendment to First Amended and Restated Credit and Security Agreement, dated as of August 24, 2020, by and among the Borrower, the Guarantors, the Lenders and the Administrative Agent, and (iii) Third Amendment to First Amended and Restated Credit and Security Agreement, dated as of even date herewith, by and among the Borrower, the Guarantors, the Lenders and the Administrative Agent (as amended through the date hereof and as may be further amended, modified, supplemented or restated from time to time, the "**Credit Agreement**"; all capitalized terms used herein and not defined herein have the meanings given in the Credit Agreement), each Grantor has granted to the Administrative Agent (for itself and for the benefit of the Lenders), a mortgage on, pledge of and security interest in, all right, title and interest of such Grantor in and to the Trademarks, together with all the goodwill of the business symbolized by the Trademarks, and the registrations or applications for registration thereof, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the "**Trademark Collateral**") to secure the payment and performance of the Obligations; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, each Grantor does hereby confirm its grant to the Administrative Agent (for itself and for the benefit of the Lenders) of a mortgage on, pledge of and security interest in the Trademark Collateral to secure prompt payment and performance of the Obligations.


