**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of March 15, 2022 (the “Effective Date”), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as collateral agent for the Secured Parties (in such capacity the “Collateral Agent”), in favor of KRATON POLYMERS U.S. LLC, a Delaware limited liability company, and ARIZONA CHEMICAL COMPANY, LLC, a Delaware limited liability company (each a “Grantor” and together the “Grantors”). All capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Pledge and Security Agreement by and among the Grantors, the other grantors party thereto and the Collateral Agent, dated as of January 6, 2016 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors executed and delivered a Trademark Security Agreement, dated as of January 6, 2016 (the “Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on January 7, 2016 at Reel/Frame 5704/0485 (with respect to Kraton Polymers) and at Reel/Frame 5704/0493 (with respect to Arizona Chemical);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in, to and under all of the Secured Trademarks of such Grantor, but excluding intent-to-use Trademark applications to the extent set forth therein (collectively, the “Trademark Collateral”);

WHEREAS, on March 6, 2020, the Collateral Agent released its security interest in a portion of the Trademark Collateral pursuant to a Release of Security Interest in Specified Trademarks, which was recorded in the USPTO on March 6, 2020 at Reel/Frame 6884/0422; and

WHEREAS, the Grantors have requested the Collateral Agent to terminate and release the Security Interest in the remaining Trademark Collateral, including the Trademarks listed on Schedule A (the “Released Trademark Collateral”).


NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in the Released Trademark Collateral, and (iii) re-assigns to each Grantor any right, title or interest it may have in the Released Trademark Collateral of such Grantor, in each case without recourse to the Collateral Agent and without representation or warranty of any kind.

Each Grantor, any successor to such Grantor (including any person or entity hereafter holding any right, title or interest in or to the Released Trademark Collateral of such Grantor) and such Grantor’s designee are hereby authorized to record this Release in the USPTO.


