TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "Release"), dated this 8th day of February, 2022 (the "Effective Date"), is made by Escalate Capital Partners SBIC III, LP (the "Lender"), the security interest being released hereunder having been granted under and pursuant to that certain Intellectual Property Security Agreement entered into on or about November 6, 2019 (the "Intellectual Property Security Agreement") between Lender, Movista, Inc. ("Movista") and South49 Solutions, Inc. ("South49"; and together with Movista, the "Borrowers"). The Lender now wishes to release and terminate its security interest in the trademarks of South49 set forth in Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender, without recourse, representation or warranty of any kind (either express or implied), agrees to perform, and hereby does perform, the following acts, deeds, authorizations, permissions, and releases:


1. **Release.** Lender hereby forever releases and terminates all of its right, title and interest in, to and under the Intellectual Property Security Agreement in the trademarks set forth in Schedule A attached hereto, all goodwill associated with such trademarks and all proceeds of any and all of the foregoing, and agrees that all security interest in such trademarks is hereby discharged, terminated and released.

2. **Authorization.** Lender hereby authorizes South49 and its successors, assigns, representatives, and agents to record this Release with the USPTO, and the USPTO is authorized to receive and record this Release with the same authority as the Lender would have if recording this Release itself.
