RELEASE OF SECURITY INTERESTS IN TRADEMARK

This RELEASE OF SECURITY INTERESTS IN TRADEMARK (this "**Release**"), dated as of February 11, 2022 (the "**Effective Date**"), is made by UBS AG, Stamford Branch, in its capacity as the Security Trustee (as defined below), in favor of Aristocrat Technologies Australia PTY Limited ("**ATA**") (the "**Grantor**"), and its successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Syndicated Facility Agreement, dated as of May 21, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Facility Agreement**"), by and among Aristocrat Leisure Limited ("**Holdings**"), Aristocrat International Pty Ltd ("**AIP**"), ATA, Aristocrat Technologies, Inc. ("**ATI**") and Video Gaming Technologies, Inc. ("**VGT**") (collectively with AIP, ATA and ATI, the "**Borrowers**"), the lenders from time to time parties thereto (the "**Lenders**") and UBS AG, Stamford Branch, as administrative agent for the Lenders and as security trustee (in such capacity as security trustee, the "**Security Trustee**"), the Grantor entered into (i) that certain General Security Deed dated as of May 21, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**General Security Deed**") between, among others, each of the Grantor and the Security Trustee and (ii) that certain Trademark Security Agreement, dated as of March 11, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Trademark Security Agreement**" and, collectively with the General Security Deed, the "**Specified Security Agreements**") between, among others, the Grantor and the Security Trustee;

WHEREAS, pursuant to the Specified Security Agreements, the Grantor assigned, transferred and granted to the Security Trustee, for the benefit of the Secured Parties (as defined in the Facility Agreement), a security interest in the Trademark Collateral (as defined below);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel 7233, Frame 0640 on March 15, 2021;

WHEREAS, the Grantor has requested that the Security Trustee enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest that the Security Trustee may have in the Trademark Collateral for the benefit of the Secured Parties (as defined in the Facility Agreement) pursuant to the Specified Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Trustee hereby agree as follows:

1. **Trademark Collateral.** "**Trademark Collateral**" means (i) the trademarks and trademark applications set forth on Schedule 1 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all rights to obtain renewals and extensions thereof, (ii) any and all license and other agreements in which the Grantor has granted or is granted a license or other right under any of the foregoing, (iii) all rights to sue at law or in equity for any infringement or other violations of any of the foregoing, (iv) all Proceeds (as defined in the General Security Deed) of any of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect to any of the foregoing, and (v) all other rights of any kind accruing under any of the foregoing or pertaining to any of the foregoing throughout the world.

2. **Release of Security Interests.** The Security Trustee, on behalf of itself and the Secured Parties (as defined in the Facility Agreement) and their respective successors, legal representatives and assigns, hereby (i) terminates, releases and discharges any and all security interests that it has pursuant

to the Specified Security Agreements in, to and under the Trademark Collateral and (ii) reassigns to the Grantor any and all right, title and interest that the Security Trustee may have pursuant to the Specified Security Agreements in, to and under the Trademark Collateral.

3. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO PRINCIPLES OF CONFLICTS OF LAWS TO THE EXTENT THAT THE SAME ARE NOT MANDATORILY APPLICABLE BY STATUTE AND THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION WOULD BE REQUIRED THEREBY.


