**NOTICE OF TERMINATION AND RELEASE  
OF GRANT OF SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (the “Release”), is made effective as of February 18, 2022 by and from MIDCAP FINANCIAL TRUST, a Delaware statutory trust, in its capacity as administrative agent for the “Lenders” referred to in the Credit Agreement described below (in such capacity, the “Administrative Agent”), in favor of THE RITEDOSE CORPORATION, a South Carolina corporation whose address is 1 Technology Circle, Columbia, South Carolina 29203 (the “Grantor”).

WHEREAS, reference is made to the Credit and Guaranty Agreement, dated as of September 13, 2017 (as has been amended, restated, amended and restated, replaced, supplemented or otherwise modified from time to time, including all annexes, exhibits and schedules thereto, the “Credit Agreement”), by and among the Grantor, the other affiliates of the Grantor party thereto, the financial institutions from time to time party thereto as Lenders (as defined therein), and Administrative Agent;

WHEREAS, pursuant to the Credit Agreement, the Grantor granted the Administrative Agent a lien on and a security interest in all present and future rights, title and interest in Grantor’s Trademarks;

WHEREAS, pursuant to that certain Trademark Security Agreement (the “Security Agreement”) dated as of September 13, 2017, by and between the Grantor and the Administrative Agent, recorded with the United States Patent and Trademark Office (“USPTO”) at Reel/Frame: 6154/0126, the Grantor granted the Administrative Agent a security interest in all of the Grantor’s right, title and interest in the Grantor’s Trademarks including, without limitation, the Trademarks set forth on Schedule A attached hereto, in each case as security for the payment and performance of certain obligations, as described in the Security Agreement; and

WHEREAS, the Administrative Agent has agreed to (a) release any and all liens and security interests it may have in the Trademarks pursuant to the Security Agreement, and (b) provide a document suitable for recording in the USPTO evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademarks and has duly authorized the execution, delivery and performance of this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent agrees as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release have the meanings provided in the Security Agreement.

SECTION 2. Release of Security Interest. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (a)

terminates the liens and security interest created under the Security Agreement in the Trademarks; (b) releases and relinquishes its security interest in, to or under all Trademarks; and (c) discharges any and all rights, title and interest it has in and the security interest granted in the Trademarks, including without limitation, such Trademarks set forth on Schedule A hereto.

SECTION 3. Release of the Security Agreement. This Release has been executed and delivered by the Administrative Agent for the purpose of releasing the security interest of the Administrative Agent in the Trademarks in the USPTO. The Administrative Agent hereby authorizes Grantor to file this Release in the USPTO.


