**CERTIFICATE OF CONVERSION BY A GEORGIA CORPORATION TO
BECOME A GEORGIA LIMITED LIABILITY
COMPANY PURSUANT TO O.C.G.A. § 14-11-212**

Article I.

The name of the Georgia corporation making the election to convert to a limited liability company is Formetco, Incorporated a Georgia corporation organized under the laws of the State of Georgia. Formetco, Incorporated is referred to in this Certificate of Conversion as the "Corporation."

Article II.

The Corporation elects to become a limited liability company under the Georgia Limited Liability Company Act, O.C.G.A. §14-11-100, *et seq.*

Article III.

The name of the limited liability company to be formed by the conversion is "Formetco, LLC".

Article IV.

This election shall become effective on the date of filing with the Secretary of State of the State of Georgia.

This election to convert to a Georgia limited liability company has been approved by all of the shareholders of the Corporation in accordance with O.C.G.A. § 14-11-212(a).

With this Certificate of Conversion, Articles of Organization in the form required by O.C.G.A. § 14-11-204 are being filed with the Georgia Secretary of State, using a name that satisfies the requirements of O.C.G.A. § 14-11-207, and such articles shall govern the limited liability company being formed by this election, unless and until modified in accordance with the Georgia Limited Liability Company Act.

Article VII.

The members of the limited liability company being formed from the Corporation, pursuant to this conversion, have entered into an operating agreement that is effective immediately upon the effectiveness of this conversion, and such operating agreement provides for the basis and method of converting the ownership interests as they existed in the Corporation prior to this election into the respective ownership interests of members in the limited liability company being formed by this election.
