TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of March 14, 2022 in favor of Specialty Metals Holdco, LLC, a Delaware limited liability company ("Holdings"), Temperform, LLC, a Delaware limited liability company (the "Company"), The C.A. Lawton Co., a Wisconsin corporation ("Lawton"), Damascus Steel, LLC, a Delaware limited liability company ("Damascus"), and Damascus Real Estate, LLC, a Delaware limited liability company ("DRE"); Holdings, the Company, Lawton, Damascus and DRE are referred to herein, collectively, as the "Grantors" and, individually, as a "Grantor"), by The Huntington National Bank (successor by merger to TCF National Bank) ("Lender").

WHEREAS, pursuant to the terms and conditions of that certain Patent, Copyright, License and Trademark Security Agreement dated as of December 11, 2019 (the "Security Agreement") executed by Grantors in favor of Lender, each Grantor granted to Lender a security interest in all of such Grantor's right, title and interest in and to the trademark applications and registrations set forth on Schedule 1 attached hereto (collectively the "Trademarks");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on December 11, 2019 at Reel/Frame 6813/0113.

WHEREAS, Lender wishes to release its security interest in the Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates the Security Agreement and hereby terminates, cancels and releases any security interest it may have in the Trademarks.

Lender shall take all further actions, and provide to Grantors all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release. Each Grantor is hereby authorized to file and record this Release with the appropriate governmental agency or authority as evidence of the release of security interest granted hereunder.
