USA TRADEMARK DEED OF ASSIGNMENT

WHEREAS, ASSIGNEES are desirous of acquiring all of ASSIGNOR'S rights, title and interest in and to the Mark, the registration thereof, U.S. Reg. No. 5970104, the goodwill of the business symbolized thereby, and the right to all claims against third parties for damage and compensation relating to or arising from the use and registration of the Mark and/or the registration thereof, U.S. Reg. No. 5970104, with the right to sue for and collect the same;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby transfer, convey and assign unto ASSIGNEES in equal parts, and ASSIGNEES hereby accept, ASSIGNOR'S rights, title and interest in and to the Mark, the registration thereof, U.S. Reg. No. 5970104, the goodwill of the business symbolized thereby, and the right to all claims against third parties for damage and compensation relating to or arising from the use and registration of the Mark and/or the registration thereof, U.S. Reg. No. 5970104, with the right to sue for and collect the same;

ASSIGNOR further agrees to execute any other or further documents which may be reasonably necessary for the protection or perfection of any right, title, or interest herein acquired by ASSIGNEES.
