

FIRST: The name of the surviving limited liability company is Amika LLC, a Delaware limited liability company ("*Amika*"), and the name of the corporation being merged with and into this surviving limited liability company is Heat Make Sense, Inc., a New York corporation ("*Merging Entity*").

SECOND: The Plan and Agreement of Merger, dated as of November 30, 2021, by and between Amika and Merging Entity (the "*Merger Agreement*") has been approved, adopted, certified, executed and acknowledged by each of the constituent entities in accordance with Section 18-209 of the Limited Liability Company Act of the State of Delaware.
