**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of March 17, 2022 (the “Effective Date”), is made by UMB Bank National Association, a national banking association organized and existing under the laws of the United States, (the “Collateral Agent”), in favor of the grantor identified on the signature page hereto (the “Grantor”).

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of November 6, 2020, by and among the Collateral Agent, the Grantor and the other grantors party thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), and pursuant to the Trademark Security Agreement dated November 6, 2020 and recorded with the United States Patent and Trademark Office on November 12, 2020 at Reel/Frame 7104/0352 (the “Trademark Security Agreement”), the Grantor granted to the Collateral Agent for the benefit of the DIP Secured Parties a security interest in and continuing lien on, all of the Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to that certain Payoff Letter, dated as of March 17, 2022, by and among the Grantors, the other signatories party thereto and the Collateral Agent, the Grantors have requested that the Collateral Agent, and the Collateral Agent has agreed to, among other things, (a) release any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreement and Trademark Security Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, cancellation, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.
2. Release. In accordance with the written request of the Grantor, the Collateral Agent, for itself and for the benefit of the DIP Secured Parties, without representation or warranty of any kind, hereby releases, discharges, terminates, relinquishes and cancels, in its entirety, for the benefit of the Grantors, and their successors and assigns, all of its security interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto, arising under the Security Agreement and the Trademark Security Agreement and re-assigns, re-transfers and re-conveys to the Grantor any and all right, title and interest it may have in, to or under the Trademark Collateral.
3. Termination. In accordance with the written request of the Grantor, the Collateral Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.
4. Further Assurances. The Collateral Agent hereby authorizes the Grantor to make filings with the United States Patent and Trademark Office and agrees to take all further actions, and provide to the Grantor and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to evidence the release and


termination of the Collateral Agent's security interest in the Trademark Collateral and to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.
