TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made as of March 6, 2022 by and between Elkay Manufacturing Company, a Delaware company ("Assignor"), and Elkay Interior Systems International, Inc., a Delaware company (the "Assignee").

WHEREAS, pursuant to the spin-off of Assignor's Interior Systems business (the "Business") in which all assets used primarily by or primarily in the operation of the Business are being transferred to Assignee, Assignor has agreed to transfer and assign, and Assignee has agreed to acquire and accept, certain assets of Assignor related to the Business, including the Assigned Trademarks; and

WHEREAS, Assignee desires to acquire and accept all Assignor's right, title and interest in and to the Assigned Trademarks.

NOW, THEREFORE, for good and valuable consideration paid to Assignor by Assignee, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignment of Trademarks. Effective as of the date hereof, Assignor sells, transfers, conveys, assigns and delivers to Assignee and Assignee accepts all right, title and interest of Assignor in and to (i) all right, title and interest of Assignor in and to the trademarks set forth on Exhibit A attached hereto, (ii) the registrations and applications for registrations thereof (including intent-to-use applications), all rights therein provided by Applicable law, and all reissues, extensions and renewals of any of the foregoing and (iii) the goodwill symbolized by or associated with any of the foregoing (collectively, the "Assigned Trademarks").

2. Relationship with the Asset Transfer Agreement. For the avoidance of doubt, nothing in this Assignment will be deemed to supersede, enlarge or modify any of the rights or obligations of any party under that Asset Transfer Agreement dated as of February 19, 2022 by and between Assignor, on the one hand, and Assignee, on the other hand (the "Asset Transfer Agreement"), all of which will survive the execution and delivery of this Assignment as provided in, and subject to the limitations set forth in, the Asset Transfer Agreement. If any conflict exists between this Assignment and the Asset Transfer Agreement, the Asset Transfer Agreement will govern and control.

3. Further Assurances. Assignor hereby undertakes to give to Assignee all assistance necessary to the end of finalizing the assignments contemplated by this Assignment in favor of Assignee even, where necessary, by appointing an attorney-in-fact duly empowered to carry out all the actions necessary for such purpose.

4. Successors. This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of Assignor and Assignee.

5. Governing Law. This Assignment shall be governed by, and construed in accordance with (i) the laws of the United States, in respect to trademark issues, and (ii) in all

other respects, including as to validity (except for trademark issues), interpretation and effect, by the State of Delaware, without giving effect to the conflict of laws rules thereof.


