TRADEMARK LICENSE AGREEMENT RECORDATION

THIS TRADEMARK LICENSE AGREEMENT RECORDATION ("Recordation") is effective as of March 17, 2022 and entered into by and between The J.M. Smucker Company, an Ohio corporation ("Licensor") and TruRoots, LLC, a Delaware limited liability company (f/k/a Smucker Natural Foods, Inc.) ("Licensee"). Licensor and Licensee may each be referred to as a "Party" and together as the "Parties."

WHEREAS, Licensor is the exclusive owner of the entire right, title and interest, in and to the Licensed Trademarks (as defined below);

WHEREAS, the Parties are party to that certain Trademark License Agreement dated as of January 31, 2022 (as may be amended, supplemented, amended and restated or otherwise modified from time to time), whereby Licensor granted Licensee an exclusive license to use the Licensed Trademarks in connection with certain products; and

WHEREAS, the Parties desire to record the existence of such Trademark License Agreement with the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the foregoing and in further consideration of the respective covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and subject to all applicable terms and conditions of the Trademark License Agreement, which are incorporated herein by reference, the Parties agree as follows:

1. License Grant. Pursuant to the Trademark License Agreement, Licensor granted Licensee an exclusive license to use the trademarks "Santa Cruz," "Santa Cruz Organic" and "Radiant Rosé" and other trademarks described in the Trademark License Agreement (including, without limitation, the trademark registrations and applications listed on Schedule A attached hereto) (all of the foregoing trademarks, together with the goodwill associated therewith, collectively, the "Licensed Trademarks") in connection with the research, development, manufacturing, packaging, production, distribution, marketing, offering for sale and sale of certain products worldwide.
2. Further Assurances. Upon reasonable request of a Party, the other Party shall execute and deliver documents and provide such Party with cooperation and assistance to effectuate the terms of this Recordation.
3. Miscellaneous.
 - (a) The terms of this Recordation shall not modify the applicable terms and conditions of the Trademark License Agreement. In the event of any conflict or inconsistency between the terms of this Recordation and the Trademark License Agreement, the terms of the Trademark License Agreement shall control with respect to such conflict or inconsistency.
 - (b) This Recordation, including the validity hereof and the rights and obligations of the Parties hereunder shall be construed in accordance with and governed by the laws of the State of Delaware applicable to contracts made and to be executed entirely in such state (without giving effect to the conflicts of law provisions thereof).
 - (c) This Recordation may be executed in counterparts, each of which shall be deemed to be an original and all of which together shall be deemed to be one and the same instrument. Both

Recordation, including any document adopting any of the foregoing, may be executed by each Party electronically, via facsimile signature or by a digitally-generated signature which demonstrates the intent of the Party to be bound by the terms of this Recordation. (See, "Electronic Signature" as defined in the ESIGN Act, 15 U.S.C. §7001 et seq.). Both Parties agree that such manifestation of intent to be bound evidenced by a digitally-generated signature is equally valid and enforceable as a handwritten signature in order to bind each Party.
