RELEASE OF CHASE MANHATTAN BANK INTEREST IN TRADEMARKS

This RELEASE OF CHASE MANHATTAN BANK INTEREST IN TRADEMARKS (this "Release"), dated as of this 18th day of March, 2022, and is entered into by and between JPMorgan Chase Bank, N.A. as successor to Chase Manhattan Bank, having an office at 10 S. Dearborn, Chicago, IL 60603 ("Secured Party"), and Kenover Marketing Corp., a New Jersey corporation with its principal place of business at 72 New Hook Road, Bayonne, New Jersey 07002 ("Kenover").

WHEREAS, pursuant to the terms and conditions of those certain security agreements by and between Secured Party and The B. Manischewitz Company, LLC, formerly a limited liability company formed under the State of Delaware ("Grantor"), detailed below:

Security Agreement dated May 1, 1998 recorded on May 4, 1998 at Reel 1729, Frame 0004;

Security Agreement dated November 1, 2000 recorded on December 13, 2000 at Reel 2200, Frame 0604; and

Security Agreement dated January 31, 2000, recorded March 7, 2000 at Reel 2051, Frame 0236 and corrected filings at Reel 2119, Frame 0278 and Reel 2139, Frame 0669

(hereinafter, collectively the "Security Agreements") by which Grantor granted to and in favor of Secured Party a security interest in and to all of Grantor's right, title and interest in, to and under the trademarks, and registrations of and applications to register the foregoing, owned by Grantor, including, without limitation, the trademarks listed on Schedule A attached hereto (collectively, the "Trademarks"), in each case, together with the proceeds of any and all of the foregoing;

WHEREAS, pursuant to the terms and conditions of that certain Change of Name dated October 18, 2004, and recorded on:

November 18, 2004, at Reel 3083, Frame 0871;

Grantor changed its name to R.A.B. Food Group, LLC;

WHEREAS, pursuant to the terms and conditions of that certain Assignment of Trademarks dated August 8, 2019 and recorded on:

August 22, 2019 at Reel 6726, Frame 0464,

R.A.B. Food Group, LLC assigned certain trademarks, including the Trademarks, to Kenover;

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Secured Party absolutely and unconditionally terminates, cancels, discharges and releases, without recourse, representation or warranty of any kind, any and all security interests it has against the Trademarks pursuant to the Security Agreement or otherwise.


Secured Party shall reasonably cooperate with Kenover (at the sole cost and expense of Kenover) and its successors, assigns or other legal representatives, and provide such documents or other instruments, as reasonably requested by Kenover to more fully and effectively effectuate the purposes of this Release.

Secured Party expressly acknowledges and affirms that upon execution hereof, it shall have no rights and remedies with respect to the Trademarks.


