RELEASE OF SECURITY INTEREST

This RELEASE, dated as of March 18, 2022 is made by CIBC BANK USA, formerly known as The PrivateBank and Trust Company (“CIBC”), having its principal place of business at 120 S. LaSalle St., Chicago, IL 60603.

WHEREAS, CIBC entered into the security agreement, dated as of September 30, 2016 (the “Agreement”), with Lawson Products, Inc., an Illinois corporation (“Borrower”).

WHEREAS, in connection with the Agreement, Borrower granted and pledged to CIBC a security interest in and to the right, title and interest in and to all of its owned or existing and thereafter acquired or arising trademarks, trade names, corporate names, company names, business names, designs, fictitious business names, trade styles, service marks, logos, other business identifiers, prints and labels on which any of the foregoing have appeared or appear, all registrations and recordings thereof, and all applications in connection therewith, including, without limitation, the trademark registrations and applications listed on the attached Exhibit A hereto, including without limitation all rights corresponding thereto throughout the world and all renewals, extensions and continuations-in-part thereof, all proceeds of license royalties and infringement suits, the rights to sue for past, present and future infringements of any of the foregoing (all of the foregoing are sometimes hereinafter individually and/or collectively referred to as the “Trademarks”); and all rights corresponding thereto in the United States and the goodwill of the business to which each of the Trademarks relates;

WHEREAS, the security interest was recorded in the United States Patent and Trademark Office at reel/frame 5900/0704, on October 14, 2016; and

WHEREAS, CIBC has consented to the release of its interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is acknowledged, CIBC hereby releases the security interest in, to and under the Trademarks, including those identified on Exhibit A.
