ASSIGNMENT OF TRADEMARKS AND SERVICE MARKS

Said Asset Purchase Agreement listed assets to be transferred in Schedule 1.1, specifically:

WHEREAS on February 13, 2019, Asteri Networks LLC, (a Louisiana limited liability company) acquired Trademarks and Service Marks from their prior owner Random House, LLC (a Delaware limited liability company located and doing business at 1745 Broadway, New York, NY 10019) and;

WHEREAS on March 6, 2019, Asteri Networks LLC, assigned all its rights, titles and interests in and to the Trademarks and Service Marks acquired from Random House, LLC to its corporate entity Asteri Networks, Inc. (a Delaware corporation) and;

WHEREAS Assignors Asteri Networks Inc., and Asteri Networks LLC, hold Trademarks and Service Marks and/or outstanding applications or renewals or the right to renew said Trademarks and Service Marks in the United States, the European Union, Australia, Singapore, and Canada;

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:


1. For One Dollar and other good and valuable consideration, the receipt of which is hereby acknowledged by the Assignors, the Assignors hereby assign to the Assignee all the rights, title, and interest in and to the Trademarks and Service Marks, including the right to file further applications in any country for said Trademarks and Service Marks and to receive registrations therefore, and also including the rights, title and interest to any goodwill connected with any use of said Trademarks and Service marks. listed in the attached Schedule A.
2. The Assignors and the Assignee agree to execute all other documents which may be useful and necessary to give effect to the foregoing or to establish that the Assignor does not have any other right, title, and interest in and to the Trademarks and Service and any outstanding Applications or renewals of said Trademarks and Service Marks.

3. This Assignment shall be governed by and construed in accordance with the laws of the State of New York, without regard to principles of conflicts of laws.
