**ACKNOWLEDGEMENT OF SECURITY INTEREST
IN TRADEMARKS AND DOMAIN NAMES**

THIS ACKNOWLEDGEMENT OF SECURITY INTEREST IN TRADEMARKS AND DOMAIN NAMES (this "Agreement"), dated as of March 23, 2020, is made by **PANTHERX SPECIALTY LLC**, a Pennsylvania limited liability company ("PANTHERx Specialty"), and **PANTHERX ACCESS SERVICES LLC**, a Pennsylvania limited liability company ("PANTHERx Access"), and together with PANTHERx Specialty, collectively the "Grantors" and each, individually, a "Grantor") in favor of **THE HUNTINGTON NATIONAL BANK** (the "Lender").

W I T N E S S E T H:

WHEREAS, the Grantors have entered into that certain Amended and Restated Credit Agreement dated as of the date hereof (as amended, amended and restated, extended, supplemented or otherwise modified in writing from time to time, the "Credit Agreement") with Lender.

WHEREAS, to secure the Obligations (as defined in the Credit Agreement) under the Credit Agreement, the Grantors have entered into that certain Security Agreement dated as of the date hereof (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in favor of the Lender; and

WHEREAS, pursuant to the Security Agreement, each Grantor has granted to Lender a security interest in such Grantor's intellectual property, including, without limitation, Trademarks (as defined in the Security Agreement) and domain names of such Grantor; and

WHEREAS, each Grantor has duly authorized the execution, delivery and performance of this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, capitalized terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement.

SECTION 2. Grant of Security Interest. Each Grantor hereby confirms that pursuant to the Security Agreement, such Grantor has granted to the Lender a security interest in all of the Trademarks and domain names of such Grantor (including, without limitation, those items listed on Schedule A hereto), any and all goodwill associated therewith, and all proceeds and products of any and all of the Trademarks or domain names of such Grantor, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Secured Obligations.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Grantors for the purpose of recording the security interest granted pursuant to the Security Agreement with

the United States Patent and Trademark Office. This Agreement is expressly subject to the terms and conditions of the Security Agreement. The Security Agreement (and all rights and remedies of the Secured Party thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. Acknowledgement. The Grantors hereby further acknowledge and affirm that the rights and remedies of the Lender with respect to the security interest in the Trademarks and domain names are fully set forth in the Credit Agreement and the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.


SECTION 5. Counterparts. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.


