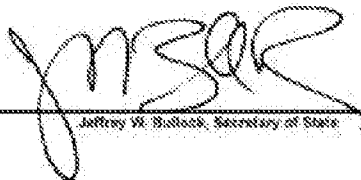

5. The merger is to be effective on January 1, 2022 at 12:00 a.m.

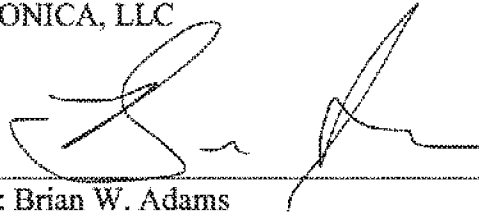
