Assignment Agreement

This Assignment Agreement (this "Agreement"), dated February 1, 2015, is between DNA LLC ("DNA") and Habitat Skateboards LLC (the "Assignee"), a wholly owned subsidiary of DNA.

WHEREAS, the parties wish to enter into this Agreement for DNA to assign the IP over to the Assignee:

The parties agree as follows:

1. The "IP" for purposes of this agreement is described as:

Any and all intellectual property containing the "Habitat" name or mark, and any related copyrights and/or trademarks owned by DNA. This assignment shall include all costs and benefits associated with the IP, included revenue related to the license of same.

Assignment

2. DNA hereby assigns to Assignee all right, title, and interest to the IP and all proprietary rights, including all copyrights and all goodwill associated with same.

Representations and Warranties

3. DNA represents and warrants that:
 - 3.1 That DNA has the power to convey all rights granted and assigned in this Agreement.
 - 3.2 DNA has full power and authority to enter into this Agreement. Assignor agrees to defend, indemnify, and hold harmless Assignee, for any claims, suits or proceedings alleging a breach of these warranties.

Consideration

4. Assignee is the wholly owned entity of DNA, operating for the benefit of DNA to which all benefits of the IP continue to flow. The parties agree that no additional consideration shall thus be required.




