**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Intellectual Property Security Agreement (this “**Termination**”), dated as of March 18, 2022, is executed by SILICON VALLEY BANK, a California corporation (“**Bank**”), in favor of FULLBAY INC., a Delaware corporation (“**Company**”). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

**RECITALS**

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of July 23, 2020 (“**Security Agreement**”), executed by Company in favor of Bank, Company granted to Bank a security interest in all of the Copyrights, Trademarks, Patents, and Mask Works (collectively hereinafter the “**Intellectual Property**”), including the Intellectual Property identified on Exhibit A attached hereto (the “**Released Intellectual Property**”).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on July 24, 2020 at Reel 7007 and Frame 0332, to evidence the security interest granted under the Security Agreement.

C. Bank agrees to terminate and release its security interest in the Released Intellectual Property specified below.

**AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby agrees as follows:

(a) Bank hereby terminates and releases its security interest in the Released Intellectual Property, and Bank hereby assigns and transfers to Company, without any representation, warranty, or recourse whatsoever, Bank’s entire right, title, and interest in and to the Released Intellectual Property, effective as of the date set forth above.

(b) Bank represents and warrants that it has the full power and authority to execute this Termination.

(c) Bank authorizes and requests the Trademark and Patent Divisions of the United States Patent and Trademark Office and the United States Copyright Office to record this Termination.
