## ACKNOWLEDGMENT OF SECURITY INTEREST IN TRADEMARKS

March 18, 2022

WHEREAS, **RFX, LLC**, a Pennsylvania limited liability company and **PIONEER TRANSFER, LLC**, a Pennsylvania limited liability company (collectively, "Grantors"), have adopted, used and are using, and hold all right, title and interest in and to, the trademarks and service marks listed on the attached Schedule 1, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, Grantors have entered into that certain Second Amended and Restated Credit and Security Agreement, dated as of March 18, 2022 (as amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the "Credit Agreement") by and among certain other loan parties from time to time party thereto, the lenders party thereto (the "Lenders"), and The Huntington National Bank, a national banking association, as the administrative agent and collateral agent for itself and for the Lenders (in such capacity, the "Agent"); and

WHEREAS, pursuant to the Credit Agreement, Grantors have granted to the Agent, for the benefit of the Lenders a continuing security interest in all right, title and interest of Grantors in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations (as defined in the Credit Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Grantors and the Agent, Grantors do hereby grant to the Agent, for the benefit of the Lenders, a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the Collateral are more fully set forth in the Credit Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
