## TRADEMARK ASSIGNMENT

This Trademark Assignment (“**Assignment**”) is made and entered into by and between Ripple Labs Inc., a Delaware corporation, with an address at 300 Montgomery Street, Floor 12, San Francisco, California 94104, USA (“**Ripple Labs**” or “**Assignor**”), and Mittetulundusühing XRP Ledger Trust, an Estonian nonprofit organization with an address at Ringtee 15, Kuressaare, 93815 Saare maakond, Estonia (“**XRPLF**” or “**Assignee**”), effective as of March 1, 2021 (the “**Effective Date**”).

WHEREAS, Ripple Labs assigned to XRPLF all right, title, and interest in and to the trademarks identified in **Schedule A** to this Assignment (the “**Marks**”) to be exercised where legally permissible, together with the goodwill of the business symbolized thereby, all common law rights to the Marks, if any, all rights of action accrued, including without limitation the right to sue and recover for past infringement of the Marks and collect the same for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives for good and valuable consideration, the receipt and sufficiency of which is acknowledged by both parties;

AND WHEREAS, the Parties desire to memorialize the transfer of the Marks and all right, title, interest, and goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Parties agree as follows:

1. The Parties hereto hereby execute this Confirmatory Trademark Assignment Agreement affirming the assignment by Ripple Labs to XRPLF of all right, title, and interest in and to the Marks to be exercised where legally permissible, together with the goodwill of the business symbolized thereby, all common law rights to the Marks, if any, all rights of action accrued, including without limitation the right to sue and recover for past infringement of the Marks and collect the same for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives for good and valuable consideration, the receipt and sufficiency of which is acknowledged by both parties;
2. Ripple Labs hereby acknowledges and agrees that as of and after the Effective Date, XRPLF shall be the exclusive owner of the Marks. The Parties agree to execute whatever assignment documents are necessary to effect this assignment. XRPLF agrees to record the assignments with the appropriate trademark office. Assignor agrees to assist Assignee with recordal as needed.


