**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”), dated as of March 16, 2022, is made by JPMORGAN CHASE BANK, N.A., in its capacity as administrative agent (the “Administrative Agent”), in favor of KAMIN LLC, a Delaware limited liability company (the “Grantor”), as follows:

**WITNESSETH:**

WHEREAS, pursuant to that certain Security Agreement, dated as of October 8, 2015 (as amended, supplemented, restated or otherwise modified from time to time, , the “Security Agreement”), by and among, *inter alios*, the Grantor and the other parties party thereto in favor of the Administrative Agent, and those certain agreements described on Annex I attached hereto (the “IP Security Agreements”), the Grantor granted a security interest in certain collateral in favor of the Administrative Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Administrative Agent now desires to terminate and release the IP Security Agreements and the entirety of its security interest in the IP Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby agrees as follows:

1. **Definitions.** The term “IP Collateral”, as used herein, shall mean all of the Grantor’s right, title or interest in, or to any and all of the Trademark Collateral and Patent Collateral, including the properties listed on Annex II attached hereto. Capitalized terms not defined herein have the meanings set forth in the Security Agreement or IP Security Agreements, as applicable.

2. **Release of Security Interest.** The Administrative Agent, without recourse, representation or warranty and at the Grantor’s sole cost and expense, hereby terminates the IP Security Agreements and terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantor, and their successors and assigns, its security interest in and to the IP Collateral and any and all right, title and interest of the Administrative Agent in and to the IP Collateral. The Administrative Agent hereby authorizes the Grantor and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office, at the sole expense of the Grantor, to evidence and effectuate the release and termination of the Administrative Agent’s security interest in the IP Collateral.



Electronic signatures will have the same force and effect as manual signatures.

4. **Governing Law.** THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.


