
**GRANT OF SECURITY INTEREST IN
AND MORTGAGE OF INTELLECTUAL PROPERTY**


THIS GRANT OF SECURITY INTEREST IN AND MORTGAGE OF INTELLECTUAL PROPERTY (this "Security Agreement") is entered into to secure the full and prompt performance and payment of all the Obligations of the Grantors, as such term is defined in the Intellectual Property Collateral Assignment and Security Agreement between Grantor and Grantee, dated as of November 1, 2021 (as amended from time to time, the "Agreement"). Upon the occurrence of an Event of Default, as that term is defined in the Agreement, Grantee shall exercise its rights and remedies with respect to the Collateral. This Security Agreement has been entered into in conjunction with the intellectual property collateral assignment and security interest granted to the Grantee under the Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Security Agreement are deemed to conflict with the Agreement, the provisions of the Agreement shall govern.
