No. 5,715,777 ("the '777 Trademark") for the registered trademark "SHELL SHACK," registered on April 2, 2019, for "Providing of food and drink; restaurant, bar and catering services; serving food and drinks; serving of food and drink/beverages" in Class 043 (hereinafter "Restaurant Services"), as well as common law rights in the SHELL SHACK mark;

WHEREAS, Assignor has agreed to assign to Assignee all rights of Assignor in the '777 Trademark, including all property, right, title and interest in and to the '777 Trademark, as well as all common law rights in the SHELL SHACK mark, and the goodwill associated therewith;
