**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of January 27, 2022, by **JEFFERIES FINANCE LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, “Agent”) in favor of **LANDRY’S MCGA, INC.**, a Nevada corporation with offices at 1510 West Loop South, Houston, Texas 77027, and **LANDRY’S TRADEMARK, INC.**, a Delaware corporation with offices at 1510 West Loop South, Houston, Texas 77027 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors have executed and delivered to Agent a certain Security Agreement, dated as of October 4, 2016 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the “Security Agreement”).

WHEREAS, pursuant to the Security Agreement, the Grantors entered into a certain trademark security agreement dated April 28, 2020 (the “Trademark Security Agreement”) with Agent, which was recorded on June 5, 2020 at the United States Patent and Trademark Office at Reel 6954, Frame 0856.

WHEREAS, capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted, assigned and pledged to the Agent, under the terms of the Security Agreement and the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in all of such Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.

WHEREAS, the Agent has agreed to terminate and release its security interest in the Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby unconditionally and irrevocably releases, terminates and discharges the Security Interest in the Trademark Collateral, and assigns, transfers and conveys to Grantors (as applicable) any and all right, title and interest Agent has or may have in or to the Trademark Collateral, including the Security Interest.
