Therabody, Inc., a corporation incorporated on March 14, 2016, pursuant to the provisions of the General Corporation Law of the State of Delaware, **DOES HEREBY CERTIFY:**

FIRST: That this corporation owns 100% of the capital stock of PowerDot, Inc., a corporation incorporated on March 15, 2016, pursuant to the provisions of the General Corporation Law of the State of Delaware and that this corporation, by resolutions adopted by its Board of Directors on December 22, 2021, determined to merge into itself said PowerDot, Inc., and did adopt the following resolutions:

WHEREAS, Therabody, Inc., a Delaware corporation (this "Corporation"), lawfully owns all the outstanding stock of PowerDot, Inc., a Delaware corporation ("PowerDot"); and

WHEREAS, this Corporation desires to merge into itself PowerDot and to be possessed of all the estate, property, rights, privileges and franchises of PowerDot;

NOW, THEREFORE, BE IT RESOLVED, that this Corporation merge into itself PowerDot and assumes all of its obligations.

RESOLVED FURTHER, that an authorized officer of this Corporation be, and hereby is, directed to make and execute a certificate of ownership and merger setting forth a copy of the resolutions to merge PowerDot and assume its liabilities and obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of State of the State of Delaware.

RESOLVED FURTHER, that the officers of this Corporation be, and they hereby are, authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware, which may be necessary or proper to effect said merger.

SECOND: The merger shall be effective as of 11:59 p.m. Pacific time on December 31, 2021.

THIRD: The merger has been approved by the holders of at least a majority of the outstanding shares of stock of PowerDot by written consent in accordance with Section 228 of the General Corporation Law of the State of Delaware.
