**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of March, 25, 2022, is made by **JPMORGAN CHASE BANK, N.A.**, as Administrative Agent (the "Administrative Agent"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with that certain Credit Agreement, dated as of April 17, 2015 (as the same has since been amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), among Sprouts Farmers Market, Inc. ("Holdings"), Sprouts Farmers Markets Holdings, LLC ("Borrower"), the Lenders party thereto and Administrative Agent, the Lenders agreed to make loans and extend other financial accommodations to or for the benefit of the Borrower;

WHEREAS, Holdings, the Borrower and certain Subsidiaries of the Borrower (the "Pledgors" and each, a "Pledgor") entered into that certain Guarantee and Collateral Agreement (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), dated as of April 17, 2015 in favor of the Administrative Agent;

WHEREAS, in connection with the Credit Agreement, Security Agreement and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "IP Security Agreements"), the Pledgors granted to the Administrative Agent, for the benefit of the Secured Parties, a continuing security interest in all of Pledgors' right, title and interest in, to and under the IP Collateral (as defined in the IP Security Agreements), including those listed on Annex I attached hereto; and

WHEREAS, the IP Security Agreements were recorded in the United States Patent and Trademark Office or United States Copyright Office, as applicable, on the dates and on the reels/frames or volume/document no., as applicable, set forth on Annex I attached hereto.

NOW THEREFORE, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby irrevocably **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its continuing security interest in all of Pledgors' right, title and interest in, to and under the IP Collateral, including those listed on Annex I attached hereto, whether granted pursuant to the Security Agreement, the IP Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in, to and under the IP Collateral to the relevant Pledgor.


