**TRADEMARK RELEASE AND REASSIGNMENT**

THIS SECOND LIEN TRADEMARK RELEASE AND REASSIGNMENT is made as of March 25, 2022, by The Northwestern Mutual Life Insurance Company, as Agent (in such capacity, "Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, CSC Operating Company, LLC, a Delaware limited liability company (the "Grantor"), and Agent are parties to that certain Intellectual Property Security Agreement dated as of February 1, 2019 (the "Security Agreement"), pursuant to which Grantor granted to Agent a continuing security interest in and lien on the Trademark Collateral (as defined below);

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on February 1, 2019, at Reel 6548, Frame 0156;

WHEREAS, Grantor has requested that Agent release its security interest in and lien on the Trademark Collateral and reassign any and all rights in the same to Grantor;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Agent's security interest in and lien on the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases, discharges, terminates and cancels its liens and security interest in all right, title and interest of the Grantor in, to and under the following:

(i) all of such Grantor's right, title and interest in, to and under its United States Trademark applications and registrations, including, without limitation, those listed on Schedule I attached hereto (the "Trademark Collateral");

(ii) all renewals, extensions, proceeds and products of the Trademark Collateral;

(iii) the goodwill of the businesses connected with the use of, and symbolized by, each Trademark Collateral; and

(iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to the Trademark Collateral including, without limitation, all causes of action and rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof or unfair competition regarding the same.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademark Collateral.
