TRADEMARK ASSIGNMENT

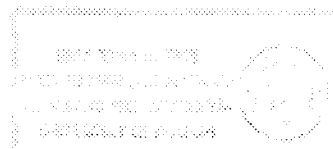

ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Mark and the Property, together with:

- (1) The goodwill of the business relating to the Product in respect upon which the Mark is used and for which it is registered, but excluding the LSFD Goodwill; and
- (2) All income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark; and
- (3) All rights to sue for past, present and future infringements or misappropriations of the Mark.





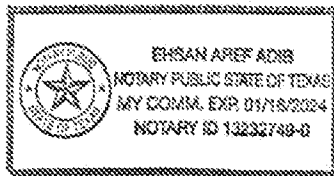
