INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the “Assignment”), effective as of September 10, 2021 (the “Effective Date”), is entered into by and among 3D Systems, Inc., a California corporation (“3D US”), Quickparts.com, Inc., a Delaware corporation (together with 3D US, the “Assignors” and each, an “Assignor”), and QuickParts Acquisition, Inc., a Delaware corporation (the “Assignee”).

RECITALS

WHEREAS, the Assignors, the Assignee, 3D Systems Italia Srl, an Italian private limited company 3D Systems France Sarl, a French private limited company, 3D Systems Europe Limited, a United Kingdom private company limited by shares, and 3D Systems Corporation, a Delaware corporation, entered into that certain Asset Purchase Agreement, dated as of June 1, 2021 (the “Purchase Agreement”); and

WHEREAS, pursuant to the Purchase Agreement and the Disclosure Schedules thereto, the Assignors have agreed to assign to the Assignee (and the Assignee has agreed to accept the assignment of), the Business Intellectual Property, including without limitation the rights identified on Schedule A attached hereto.

NOW, THEREFORE, in consideration of the foregoing and the respective representations, warranties, covenants and agreements set forth herein, and for other good and valuable consideration (including without limitation the consideration received by the Assignors pursuant to the Purchase Agreement), the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Definitions. Capitalized terms used herein and not otherwise defined herein shall have the respective meanings given to them in the Purchase Agreement.

2. Assignment. As of the Effective Date, each Assignor hereby transfers and assigns to the Assignee, and the Assignee hereby accepts, all right, title and interest in and to the Business Intellectual Property, including without limitation the rights identified on Schedule A attached hereto, and (a) all common law rights and goodwill associated with any of the foregoing, free and clear of all Liens (except for Permitted Liens), (b) any patents issuing on patent applications, divisionals, continuations, and continuations-in-part of any patent applications included in such Business Intellectual Property and any and all reissues and reexaminations of any of the foregoing, (c) claims of all foreign applications and patents that are directed to subject matter specifically described in such Business Intellectual Property, (d) any other patent claiming priority to any of the foregoing, and (e) all inventions disclosed or claimed in any of the foregoing, together with (i) all rights to royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any of the foregoing, (ii) any and all claims and causes of action arising from or with respect thereto (regardless of whether or not such claims and causes of action have been asserted by the Assignors), whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default throughout the world, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, and retain, any such damages, and (iii) equivalent rights that, now or hereafter, may be secured under the Laws of any jurisdiction, including all registrations, renewals, extensions, combinations and applications for any of the rights referred to above in this Section 2. Each Assignor authorizes and requests that the United States Patent and Trademark Office, and the corresponding entities in any foreign countries or multinational authorities (as applicable), record Assignee as owner of the Business Intellectual Property).

3. Terms of the Agreement. Each Assignor and the Assignee acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. Notwithstanding anything to the contrary herein, this Assignment is subject to the Purchase Agreement, and it shall not give rise to any recourse or remedy against the Assignors (or their Affiliates) except to the extent set forth in the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

4. Further Assurances. As and when requested by any party and at such party's expense, any other party shall execute and deliver, or cause to be executed and delivered, all such documents and instruments and shall take, or cause to be taken, all such further or other actions as such other party may reasonably deem necessary to evidence and effectuate the transactions contemplated by this Assignment (including without limitation any and all title update documents required in any jurisdiction).

5. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Assignment by facsimile or scanned PDF pages shall be effective as delivery of a manually executed counterpart to this Assignment.

6. Governing Law. This Assignment shall be governed by, and construed in accordance with, the internal Laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).

7. Successors and Assigns. This Assignment shall be binding upon, inure to the benefit of and be enforceable by, the Assignors and the Assignee and their respective permitted successors and assigns.


8. Headings. The headings of this Assignment are for reference purposes only and shall not affect in any way the meaning or interpretation of this Assignment.




