**TERMINATION AND RELEASE
OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**

WHEREAS, pursuant to the Security Agreement, the Released Party granted to the Lender a security interest in and lien on the trademarks identified on Schedule B attached hereto (the “**Trademark Collateral**”), which security interest is recorded with the USPTO on November 7, 2019 at Reel 6799, Frame 0667; and

WHEREAS, the Lender wishes to release the security interest in and lien on the Patent Collateral and the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender states as follows:

The Lender hereby terminates, releases, and discharges its security interest in and lien on the Patent Collateral and the Trademark Collateral, and the Lender hereby assigns and transfers to the Released Party without recourse or representation or warranty, express or implied, of any kind, all of its right, title and interest in and to the Patent Collateral and the Trademark Collateral, effective as of the date set forth above.

The Lender understands and agrees that this Release may be recorded by or for the Released Party with the USPTO or any similar office or agency within or outside the United States.
