TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this “Release”) is made as of March 29, 2022, by GOLUB CAPITAL LLC, in its capacity as administrative agent (in such capacity, “Agent”) in favor of Sage Dental Management, LLC, as successor in interest to Northwestern Management Services, LLC (“Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, this Release refers to that certain Trademark Security Agreement dated as of July 29, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”) pursuant to which Northwestern Management Services, LLC granted a security interest to Agent, on behalf of itself and the Secured Parties, in certain Trademarks and Trademark Collateral, including the Trademark set forth on Schedule 1 hereto;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on on August 1, 2016, at Reel 5843, Frame 0645;

WHEREAS, the Trademark Collateral was assigned to Grantor; and

WHEREAS, Grantor has requested that Agent terminate, cancel, release and discharge, on behalf of itself and the Secured Parties, its security interest in the Released Trademarks and Released Trademark Collateral (each as defined below) and reassign, grant and convey any and all rights in the same to Grantor solely with respect to such Released Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby terminates, cancels, releases and discharges its Lien on and security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral of Grantor (collectively the “Released Trademark Collateral”):

2. Agent, on behalf of itself and the Secured Parties, hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent’s right, title and interest in and to the Released Trademark Collateral.

3. Agent hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office to record this Release.

4. At the request of Grantor, Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably

requested or are required in order to more fully and effectively carry out the purpose of this Release.

5. Agent, without representation or warranty of any kind hereby terminates and cancels the Trademark Security Agreement.
