(the "*Corporation*") a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "*DGCL*"), for the purpose of amending the Corporation's Amended and Restated Certificate of Incorporation (the "*Certificate of Incorporation*") filed with the Secretary of State of Delaware on December 30, 2020, does hereby certify as follows:

FIRST: The name of the Corporation is NuArx, Inc.

SECOND: The Board of Directors of the Corporation, acting by unanimous written consent in lieu of a meeting pursuant to Section 141(f) of the DGCL, duly adopted resolutions setting forth this proposed amendment to the Certificate of Incorporation and declared such amendment to be advisable in accordance with the applicable provisions of Section 242 of the DGCL.

THIRD: Article I of the Certificate of Incorporation is hereby amended to read in its entirety as follows:

"The name of the corporation (the "Corporation") is Viking Cloud, Inc."

FOURTH: All other provisions of the Certificate of Incorporation shall remain in full force and effect.

FIFTH: This certificate of amendment shall be effective at 9:15 AM ET on June 1, 2021.
