**PARTIAL RELEASE  
OF  
SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY  
(TRADEMARKS)**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY (TRADEMARKS) (this "Agreement"), made as of March 24, 2022, by **ECLIPSE BUSINESS CAPITAL LLC** (f/k/a Encina Business Credit, LLC), in its capacity as agent ("Administrative Agent") for the itself and any other financial institution which are now or which hereafter become a party to the Credit Agreement (as defined in the Existing Agreement defined below) in favor of **DAYTONA APPAREL IP LLC**, a Delaware limited liability company ("Grantor").

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement (Trademarks), dated as of May 7, 2021 and recorded with the United States Patent and Trademark Office on May 18, 2021 at Reel 7287, Frame 0935 (as amended of record from time to time hereinafter, the "Existing Agreement"), in favor of Administrative Agent, pursuant to which the Grantor pledged, assigned and granted a security interest in certain trademarks and trademark applications (the "Marks"). All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Existing Agreement;

**WHEREAS**, Grantor and Daytona Apparel Group LLC, as the sellers, have entered into that certain Asset Purchase and Assignment Agreement dated as of even date (the "Purchase Agreement") with Centric Socks LLC, a Delaware limited liability Company, as the buyer (the "Buyer"), pursuant to which, inter alia, Grantor has agreed to sell to the Buyer certain Marks;

**WHEREAS**, in connection with the Purchase Agreement, Grantor has requested that that the Administrative Agent release and reassign to Grantor its interest in (i) the Marks identified on Exhibit A attached hereto, together with any reissues, continuations or extensions thereof (the "Specified Marks"), (ii) Grantor's rights under warranties, indemnities and all similar rights against third parties to the extent related to any Specified Marks, (iii) all goodwill associated with any of the assets described in the foregoing clauses (i) and (ii), and (iv) all products and proceeds of the foregoing, including without limitation any claim or cause of action against third parties for past, present or future (a) infringement or dilution of any Specified Marks, or (b) injury to the goodwill associated with any Specified Marks; and

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent does hereby release any and all liens and security interests it may have in and to (i) the Specified Marks specifically identified on Exhibit A attached hereto, together with any reissues, continuations or extensions thereof, (ii) Grantor's rights under warranties, indemnities and all similar rights against third parties to the extent related to any Specified Marks, (iii) all goodwill associated with any of the assets described in the foregoing clauses (i) and (ii), and (iv) all products and proceeds of the foregoing, including without limitation any claim or cause of action against third parties for past, present or future (a) infringement or dilution of any Specified Marks, or (b) injury to the goodwill associated with any Specified Marks.

The Administrative Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record this Partial Release of Security Interest in Certain Intellectual Property (Trademarks).

Except for the release of (i) the Specified Marks specifically identified on Exhibit A attached hereto, (ii) Grantor's rights under warranties, indemnities and all similar rights against third parties to the extent

related to any Specified Marks, and (iii) all goodwill associated with any of the assets described in the foregoing clauses (i) and (ii), all terms and provisions of the Existing Agreement shall remain in full force and effect. Nothing contained herein shall in any way impair the validity or enforceability of the Existing Agreement, as modified hereby, or alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein. Any lien and/or security interest granted in any Marks or any other assets other than the Specified Marks (whether pursuant to the Existing Agreement or otherwise) shall remain unchanged and in full force and effect and shall continue to secure the satisfactory payment and performance of all of the Obligations.

This Agreement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.


