TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is given as of March 29, 2022, by WEBSTER BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the "Agent") for the Lenders (as defined in the Credit Agreement referred to below) and the other Secured Parties (as defined in the Credit Agreement referred to below), in favor of EVERSTREAM SOLUTIONS, LLC, an Ohio limited liability company ("Everstream") and EVERSTREAM GLC HOLDING COMPANY LLC, a Delaware limited liability company ("GLC Holdings," and together with Everstream, the "Grantors"). Capitalized terms used herein without definition shall have the meaning given to them in the Credit Agreement (as defined below) or the Security Agreement (as defined below), as applicable.

WHEREAS, the Grantors and the Agent desire that the Agent terminate and release its Lien on, and any and all security interest the Agent may hold in, the Trademark Collateral.
