CONFIRMATION OF TRADEMARK ASSIGNMENT

This Confirmation of Trademark Assignment ("**Assignment**") is entered into by and between Cisco Systems, Inc., a Delaware corporation ("**CSI**"), as successor in interest to Cisco Systems, Inc., a California corporation ("**Cisco**") and Cisco Technology, Inc., a California corporation ("**CTI**").

WHEREAS, pursuant to a prior Asset Transfer Agreement effective August 11, 2020 between and among ThousandEyes LLC, a limited liability company organized under the laws of Delaware, Cisco, and CTI (the "**Asset Transfer Agreement**"), certain intellectual property rights, including without limitation all rights, title and interest in and to the Cisco Marks (as defined below), were assigned to CTI.

NOW, THEREFORE, CSI and CTI confirm that:


"**Cisco Marks**" means all of Cisco's trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation Cisco's trademark registrations and applications and any and all of Cisco's common law rights in the aforementioned items, together with all goodwill associated with and symbolized by the aforementioned items, including without limitation the marks identified in Schedule 1 attached hereto and all of the goodwill associated with and symbolized by such marks.

Effective August 11, 2020, Cisco has assigned and transferred, and CTI received and accepted, all of Cisco's rights, title and interest throughout the world in and to the Cisco Marks and all the rights, claims and privileges pertaining to the Cisco Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Cisco Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Cisco in all matters related thereto.

CSI hereby authorizes and requests the United States Commissioner of Patents and Trademarks and the relevant officials of foreign jurisdictions to implement this Assignment.


