WHEREAS, Assignor, in accordance with, and pursuant to, the terms and conditions of that certain Agreement and Plan of Merger, dated as of October 15, 2020, by and among CIT Group Inc., a Delaware corporation, First Citizens BancShares, Inc., a Delaware corporation, First-Trust Citizens Bank & Trust Company, a North Carolina chartered commercial bank, and FC Merger Subsidiary IX, Inc., a Delaware corporation, acquired all right, title and interest in and to the U.S. trademarks and trademark registrations listed in Exhibit A, attached hereto, together with the goodwill associated and symbolized thereby (collectively the "Marks");

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor by these presents does hereby sell, assign, transfer, and convey to Assignee, its successors, assigns, and legal representatives, the entire right, title, and interest in and to the Marks, including the goodwill associated therewith, together with the right to sue and recover for past misappropriations, infringements, dilutions, or any other violations of any proprietary or other right in and to the Marks.
