CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS, FUJIFILM Corporation, a corporation organized and existing under the laws of Japan, having a principal place of business at 26-30, Nishiazabu 2-chome, Minato-ku, Tokyo, Japan (hereinafter "Assignee");

WHEREAS, Assignor adopted, used and filed application Serial No. 75/426,732 for the trademark DURIMIDE, which issued into U.S. Registration No. 2,476,083, dated August 7, 2001 (hereinafter referred to as the "Trademark"), and Assignor is listed in the records of the United States Patent and Trademark Office (the "PTO") as registrant of U.S. Registration No. 2,476,083;

WHEREAS, Assignor agreed to assign, sell, and transfer unto Assignee the entire right, title and interest in and to the Trademark, together with the good will of the business in connection with which the Trademark is used as of October 2, 2006 ("Effective Date").

NOW, THEREFORE, IT IS HEREBY AGREED:

In consideration of the sum of One Dollar (\$ 1.00), and such other good and valuable consideration to it in hand paid, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign and transfer unto Assignee, effective as of October 2, 2006, all of its right, title and interest in and to the Trademark, including U.S. Registration No. 2,476,083, and together with the good will of the business in connection with which the Trademark is used.

2. Assignor shall do all acts and execute all documents which may be reasonably required by Assignee in order to effect the assignment to Assignee of its rights in the Trademark, including U.S. Registration No. 2,476,083.
