### AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY INTEREST

This Affidavit to Affirm the Release of Security Interest is effective as of 26-Mar-2022 | 07:29 GMT pursuant to the fulfillment of the loan obligations.

I, Phil Rogers, do hereby declare as follows.

- 1. I am the Chief Executive Officer of Square Enix Limited, a United Kingdom corporation.
- 2. Eidos Interactive, Inc. (“**Company**”) changed its name to Eidos, Inc. Eidos, Inc. is a wholly owned subsidiary of Square Enix Limited.
- 3. Pursuant to that certain Security Agreement, dated as of November 02, 2008 (the “**Security Agreement**”), Company granted Foothill Capital Corporation (the “**Lender**”) a security interest (the “**Security Interest**”) in the trademark registrations set forth on Schedule A attached hereto (the “**Trademarks**”).
- 4. The Security Agreement was recorded at the United States Patent and Trademark Office (the “**USPTO**”) on December 02, 2008 at Reel/Frame 1829/0077 with respect to the Trademarks.
- 5. To the best of my knowledge: (a) the obligations secured under the Security Agreement were satisfied; (b) Company repaid in full the loan made by Lender to Company under the Security Agreement; and (c) Lender released the Security Interest in the Trademarks.
- 6. Due to unknown reasons, a release of the Security Interest was not previously filed with the USPTO.
- 7. The undersigned, being hereby advised that willful false statement and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, declares that the facts set forth in this affidavit are true; all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.
