Pursuant to Title 8, Section 264(c) of the General Corporation Law of the State of Delaware, as amended (the "DGCL"), Tank Holding Corp., a Delaware corporation (the "Company"), in connection with the merger of Snyder Industries, LLC, a Nebraska limited liability company ("Snyder"), with and into the Company (the "Merger"), hereby certifies as follows:

FIRST: The names and states of incorporation of the constituent entities to the Merger (the "Constituent Entities") are:

Snyder Industries, LLC	Nebraska

SECOND: An Agreement and Plan of Merger, dated as of December 23, 2020 (the "Plan of Merger"), by and between the Company and Snyder, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Entities in accordance with Sections 228 and 264(c) of the DGCL and Chapter 21, Section 21-171 of the Nebraska Revised Statutes.

THIRD: Upon the effectiveness of the Merger, the Company shall be the surviving corporation (the "Surviving Entity"), and the name of the Surviving Entity shall be "Tank Holding Corp."

FOURTH: The certificate of incorporation of the Company, as in effect immediately prior to the effectiveness of the Merger, shall remain unchanged, and shall be the certificate of incorporation of the Surviving Corporation.

FIFTH: The Merger shall become effective on December 31, 2020 at 11:59 p.m. EST.

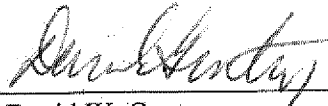
