**TERMINATION AND RELEASE  
OF SECURITY INTERESTS IN TRADEMARK COLLATERAL**

This Termination and Release of Security Interests in Trademark Collateral (the “Intellectual Property Release”) is made as of March 31, 2022, by **MIDCAP FINANCIAL TRUST** as administrative agent (the “Administrative Agent”), in favor of **TERRACARE ASSOCIATES, LLC**, a Colorado limited liability company, **TIERRA VERDE RESOURCES, LLC**, a California limited liability company, **JENSEN LANDSCAPE CONTRACTOR, LLC**, a California limited liability company and **MONARCH LANDSCAPING WA, LLC**, a Delaware limited liability company (collectively, the “Grantors”). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Trademark Security Agreements defined below.

W I T N E S S E T H:

WHEREAS, pursuant to that certain Credit and Guaranty Agreement, dated as of August 23, 2017 (as amended, restated, amended and restated, replaced, supplemented, or otherwise modified from time to time) and that certain Pledge and Security Agreement, dated as of August 23, 2017, the Grantors entered into that certain Trademark Security Agreement dated as of August 23, 2017 listed on Annex I attached hereto (the “Trademark Security Agreements”), which granted to the Administrative Agent for the benefit of the Secured Parties, a valid and continuing first priority security interest in and Lien on all of the Grantors’ right, title and interest, in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement) and which was recorded with the United States Patent and Trademark Office (the “USPTO”) as specified on Annex I.

WHEREAS, the Administrative Agent acknowledges that the conditions for releasing the security interest in the Trademark Collateral have been met, and the Grantors have requested the Administrative Agent release such security interest.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in and to any and all Trademark Collateral, including without limitation all trademark registrations applications listed on Annex II.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and intending to be legally bound, the Administrative Agent, for itself and on behalf of the holders of the Obligations, in association with the security interest under the Trademark Security Agreement, hereby, without recourse and without representation or warranty of any kind (either express or implied), (i) terminate the Trademark Security Agreement, (ii) cancel, release, terminate and discharge any and all of its right, title and interest in the Trademark Collateral of the Grantors and (iii) assign, transfer and convey to the Grantors any and all of its right, title and interest in the Trademark Collateral, as applicable.

The Grantors, or any successor to the Grantors hereby authorize the Administrative Agent to record this Release with the USPTO.


