Pursuant to Section 252 of the General Corporation Law of the State of Delaware

FIRST: The constituent corporations are Little Passports, Inc., a California corporation ("Little Passports"), and CCM Merger Sub VIII, Inc., a Delaware corporation ("Merger Sub VIII").

SECOND: An Agreement and Plan of Merger and Reorganization dated as of November 5, 2021 by and among Conscious Content Media, Inc., CCM Merger Sub VII, Inc., Merger Sub VIII, Little Passports and Fortis Advisors LLC, solely in the capacity of Representative (the "Merger Agreement"), setting forth the terms and conditions of the merger of Little Passports with and into Merger Sub VIII (the "Merger"), has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Section 252 of the General Corporation Law of the State of Delaware (the "DGCL").

THIRD: The name of the surviving corporation in the Merger (the "Surviving Corporation") is CCM Merger Sub VIII, Inc.

FOURTH: Upon the effectiveness of the Merger, the Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation (the "Certificate"), and said Certificate shall continue in full force and effect until amended and/or changed in the manner prescribed by the provisions of the DGCL.

FIFTH: An executed copy of the Merger Agreement is on file at 121 Varick Street, 3rd Floor, New York, New York 10013, the principal place of business of the Surviving Corporation.

SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation upon request and without cost to any stockholder of either constituent corporation.

SEVENTH: The Merger shall become effective upon the filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

IN WITNESS WHEREOF, the Surviving Corporation has caused this Certificate of Merger to be executed in its corporate name as of the 15th day of November, 2021.
