RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

March 31, 2022

WHEREAS, Waxman Consumer Products Group Inc., a Delaware corporation ("Grantor"), pursuant to a certain Intellectual Property Security Agreement dated as of October 30, 2018 ("IP Security Agreement"), and recorded in the United States Patent and Trademark Office granted to The Huntington National Bank, a national banking association, together with its successors and assigns ("Huntington"), a security interest in all of Grantor's right, title and interest in, to and under the IP Collateral (as defined in the IP Security Agreement), including without limitation the intellectual property listed on Exhibit A attached hereto and the goodwill associated therewith (collectively, the "Released IP");

WHEREAS, Grantor, pursuant to that certain Asset Purchase Agreement dated as of March 31, 2022 ("APA"), by and between Grantor and Homewerks Worldwide, LLC, a Delaware limited liability company ("Purchaser") sold to Purchaser and Purchaser purchased certain of Grantor's assets, other than Excluded Assets (as defined in the APA) (such purchased assets, the "Acquired Assets");

WHEREAS, Huntington wishes to terminate and release, without representation or warranty, all of Huntington's liens upon and right, title and interest in and to the Released IP;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Huntington hereby terminates and releases, without representation or warranty, all of Huntington's liens upon and right, title and interest in and to the Released IP.
