TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of March 31, 2022, by PNC Bank, National Association, as administrative agent (the "Agent") in favor of MB Precision Company, a Delaware corporation (the "Company").

The Agent understands and agrees that this release may be recorded by or for the Company with the United States Patent and Trademark Office or any similar office or agency within or outside the United States.

The Agent agrees, at the request and cost of the Company, to take all further actions, and provide to the Company and its successors, assign or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Company to more fully and effectively release, terminate and extinguish any such liens and security interests upon the Trademarks.

The Agent agrees this Termination and Release of Security Interests in Trademarks shall be binding upon Agent's representatives, assigns and successors.
