Description of Mark: **The color(s) green, white and black is/are claimed as a feature of the mark. The mark consists of the words "First Line Funding Group" in the color black appearing immediately to the right of the number one in the color green with a graphic "F" in the color white appearing within the number one.**

This transfer and assignment includes the right to recover for any third party infringement thereof, regardless of whether such infringement occurred before or occurs after the effective date. This transfer to Assignee includes, without limitation, all common law rights, interests and goodwill as may have been acquired by Assignor from the use of said Subject Mark.

Assignor further agrees to execute and deliver without further consideration any further applications, assignments and documents, and to perform such other lawful acts, as may be deemed necessary to fully secure Assignee's interest as described herein.

Assignor hereby authorizes and requests any official whose duty it is to transfer ownership to transfer the Subject Mark and registration to Assignee consistent with this Assignment.

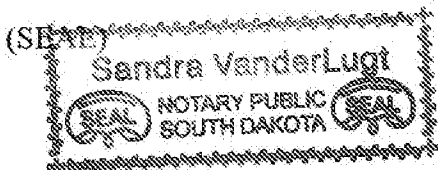

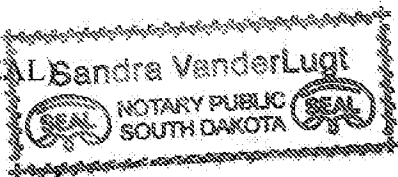
